If a person who is eligible for honorary membership chooses to pay dues and be classified as an active member, he or she shall be considered as an active member for all purposes.

Legal assistants, court and calendar clerks, legal administrators, employees of the corporation, legal support staff and mediators registered with the State Bar of Georgia Office of Alternative Dispute Resolution.
