HOW TO USE THE DIRECTORY

It is the Section's goal that lawyers will consult with, assist and refer business to one another, thereby enhancing our productivity and profits and the level of service to our clients.

HOW TO USE THE DIRECTORY

Section I

The directory consists of two sections. Section I is an alphabetical listing of the major areas of legal practice and subspecialties within each major area. Members are listed alphabetically under each subspecialty they have designated.

Section II

Section II sets out the names and complete biographical information for all attorneys participating in the Directory. This section includes the attorney's major areas of practice, if any, address, phone and fax numbers, law school, State Bar number and year admitted to the State Bar of Georgia. An attorney who has agreed to serve as a mentor is indicated after their name and a list appears in the front of the directory. An area of interest may be indicated at the end of the biographical information listed for the attorney.

Mentoring Program

Attorneys who agreed to act as a "Mentor" agree to make themselves available, without compensation, to share their experiences concerning the practice of law, including ethics, professional matters, law firm management issues and substantive areas. Contacts are expected to be suitably brief. The Mentor Program is intended to facilitate the exchange of ideas, information and experience between section members. It is not a replacement for compensated consultations, legal researching, associations or referrals.
