THE ATLANTA BAR ASSOCIATION POLL RATES CANDIDATES FOR JUDICIAL POSITIONS

ATLANTA (September X, 2010) – The Atlanta Bar Association today announces the completion of a poll rating all candidates in the contested judicial elections for Superior and State Courts for the counties of Cherokee, Cobb, DeKalb, Douglas and Fulton.

The poll asked all active and life members of the Atlanta Bar – a total of 5,474 members – to rate the 21 candidates in the upcoming November 2 elections, four of whom are incumbents. The poll provided four rating categories relating to the candidates’ credentials to hold the positions they seek: “Best Qualified for the Position,” “Well Qualified,” “Qualified,” and “Not Qualified.” To rate a candidate in any of these categories, lawyers completing the poll were asked to only vote if they had sufficient personal knowledge or other reliable information to provide an informed and thoughtful response about the candidate’s qualifications.

The Atlanta Bar Association poll also provided an option for members to respond that they have insufficient personal knowledge or other reliable information about the candidate to make a rating.

Four hundred and thirty (430) Atlanta Bar Association members responded to the poll, which was distributed by e-mail on September 8, 2010 and closed on September 22, 2010.

“We believe this judicial candidate’s poll serves as a valuable public service for the voting community,” said Michael B. Terry, president of the Atlanta Bar Association. “The aim is to provide the public with the views of lawyers responding to the poll who have sufficient knowledge of the candidates to form an opinion regarding their qualifications. The Atlanta Bar Association does not endorse candidates for judicial office and conducts these polls on an impartial basis as a public service for Metropolitan Atlanta voters.”

In order to avoid any potential misinterpretation of the poll results, publication of the poll results must be substantially the same as it appears here.
